Wie bereits in der Klageeingangsbestätigung mitgeteilt, sind die von der Verwaltungsgerichtsbarkeit und dem Bundesamt eingeholten und weitere Auskünfte des Auswärtigen Amtes, Stellungnahmen und Berichte anderer Stellen sowie die der Kammer vorliegenden Zeitungsberichte zur innenpolitischen Lage in Angola beigezogen worden und werden gegebenenfalls bei der Entscheidung verwertet. Für Angola liegen keine aktuellen Lageberichte des Auswärtigen Amtes vor. Der letzte Lagebericht stammt von 2007. Die aufgeführten Schlagworte dienen lediglich als Orientierungshilfe.
